The active ingredient, ergocalciferol is dissolved in coconut derived MCT oil and homogenized with non-GMO modified food starch and maltodextrin and then dried to a uniform powder. BHA and BHT are added as antioxidants. The Vitamin  $D_2$  contained in this product meets all requirements of USP and Ph. Eur when tested according to this compendium. Provitas®  $D_2$ -400SD is intended for the fortification of vitamin  $D_2$  in foods, beverages and powdered nutritional supplements.

The shelf life in sealed, original containers under normal storage conditions is 24 months after the date of manufacture. Store in tightly closed containers in dry conditions below 20°C. Protect from moisture, heat, light and oxygen.
